*I know that a human is not perfect. However, in my father's eyes, my mother was as perfect as she could be. In the eyes of us kids, there were times when we thought mom must be a saint. She loved Tony with all her heart, even after 63 years of being told how to do everything the 'Tony' way. And of course, we all know that that is always the only way and the 'right' way! Quiet seriously though, we should all be so lucky to experience the kind of love that Pat and Tony have for each other.*

A time that I remember when mom was glowing was when she was standing next to Susan in our living room. It was Susan's wedding day. Susan was beautiful in her wedding dress and mom was standing next to her in a pretty pink dress. Susan moved to Germany a few weeks after her wedding. This was in 1970 long before email and texting and even before affordable international calling. Mom would write letters and send Susan fun care packages. These packages included the necessities of life that couldn't be found in Germany at that time - peeps and M&M's. To this day she still gets all of us peeps and M&M's.*

Kathryn Claire was named after her cousin who passed on far too early. When Claire was a toddler she looked exactly like her grandma Pat at that same age. Her grandma was so proud of Claire's leadership award and the pivotal role Claire has on her cheerleading squad. Mom was very sad when she didn't feel well enough to go to Claire's graduation party last summer. However, mom learned all about the party and got to see the pictures.*

Because these issues cross all academic lines, you can exercise your creativity to promote the project across professional boundaries. We hope you'll take advantage of this unique opportunity to collaborate with your ACHS honor society peers.

### PROGRAM OBJECTIVES FOR PARTICIPATING HONOR SOCIETIES

1. Commit to a leadership role in increasing campus and community awareness of ethical standards.
2. Engage in a dialogue between student groups regarding ethical issues.
3. Promote, encourage, and strengthen commitment to ethical behaviors at all levels of the campus community.
4. Serve as role models of ethical behavior.

5. Pursue the art and practice of making ethical decisions, and provide learning opportunities for ethical leadership among peers.
6. Learn, share, and follow ACHS guidelines for resolving ethical dilemmas.
7. Increase knowledge of and appreciation for professional codes of ethics within your discipline.

### SAMPLE PROGRAM IDEAS

1. Sponsor a public forum on ethics featuring prominent community or campus leaders.
2. Develop a *Speakers Bureau* of community leaders who will serve as guest lecturers for individual classes.
3. Sponsor a Commitment to Ethics Day/Week on campus.
4. Develop a directory of web sites addressing ethical issues. Spearhead effort for all campus organizations to

- develop and post their codes of ethics online.
5. Purchase inexpensive T-shirts promoting ethical behavior. All members wear T-shirts to classes on the same date.

## **Alfred University at International Conference**

Alfred University Professor of Finance Dr. Abderrahman Robana and graduate student Jarrod Rywolt presented during the 5th International Finance Conference (IFC5) in Tunisia March 12-14, 2009.

Rywolt, a graduate student in the MBA program, was invited to accompany Robana to present his paper, "U.S. Economic Indicators, Democratic and Republican Administrators" before distinguished professionals, teachers, and students in the field. His paper discusses "selected U.S. macroeconomic indicators and their performance under various Presidential administrators from Truman, through G.W. Bush, January 1948 through December 2008."

The selected indicators include GDP under recessions and expansion periods, unemployment, inflation, and performance in the stock market. During his discussion, predictions for the Obama administration amongst current global economic turmoil were given."

Robana, who presented "The U.S. Financial Housing Crisis and its Global Repercussions," presented in the same room before about 50 people, residing all over the world. Rywolt commented, "It was a melting pot for finance and economics," including a presentation by Andrew Prescott, a 2004 Nobel Laureate, "on the transformation of macroeconomic policy."

Rywolt continued, "I have business cards and contact information of people from France, Spain, Turkey, Romania, and Greece." He explained the sense of intensity for learning and education, further stating "Tunisia seemed isolated from the global economic crisis, and the people he met were academically impressive."

Rywolt, originally from Fairfield, CT, graduated from the University of Connecticut in 1990. He will graduate in May 2009 with an MBA from the Alfred University College of Business.

Robana has attended each of the five International Finance Conferences held in Tunisia. He has been a finance faculty member at AU since 1971, a Sam Walton Fellow since 1997, and served as the Tredennick Professor of Entrepreneurship. He is the holder of the Robana Chair in Finance and Investments, endowed by an Alfred University business alum, Mr. Richard Chilton. The DMD International Honor Society in Business has named one of its annual scholarships after him.

Robana has also served as a visiting scholar at Harvard University's Center for Middle Eastern Studies. He has done research on how to enhance student learning through simulations in the field of finance, securitization, and country risk assessment applied to China.

The experience presented an opportunity for Alfred, explained Rywolt. "I have never been across the Atlantic, and I am glad I went. It was a beautiful country; the people were warm and welcoming."
