A Letter from the President



Dr. John Lewington

All organizations face change and new horizons in their history, but I believe that Delta Mu Delta now has the strongest foundation in its 99-year history. This foundation is the result of Rich Sosnowski's visionary work, and a legacy of two

key strategies that now enrich our future.

First, our partnership with the growing Accreditation Council for Business Schools and Programs (ACBSP) is enabling DMD to develop new chapters both national and international. There has never been more pressure from government and industry for universities to demonstrate and measure the quality of their programs. Nearly all newly accredited colleges see the value of establishing a DMD chapter. A DMD chapter adds value to ACBSP accreditation process, and strengthens our partnership.

Second is the online induction system that Rich Sosnowski designed with the help of Joel Maier, University of Phoenix. The online induction system enables students eligible for DMD membership to be inducted anywhere in the world. ACBSP's internationalization of business accreditation, and the growth of online business degrees for our armed services' personnel, has resulted in significant growth in DMD's membership inductions on a global basis.

This has resulted in an 80% increase in annual membership inductions in the past five years, and annual inductions should soon exceed 10,000 members. This is helping us to control costs and increase our Forever Dollars scholarship fund. For instance, this year we awarded \$42,000 in scholarships to our most outstanding members.

The Board of Directors wishes to thank you all for your generosity in recognizing the work of Rich Sosnowski: donations to his memorial scholarship fund now exceed \$48,000.

Dr. Michael LaRocco has done a wonderful job in cross-training our office staff, and they have responded by shipping record numbers of DMD memberships. The board has begun a search for a new full-time director to build and



Sosnowski Scholarship Endowment Continues to Grow

Those of you who read the Vision regularly know that in early February this year our executive director at that time, Richard Sosnowski, died. We reported then the reaction, almost immediate and second only to the shock, that we should establish a scholarship in his name. And so we did.

Contributions began pouring in to the Society Central Office to honor his memory and the

tireless efforts to bring Delta Mu Delta to as many students as possible.

Because the sacrifices made in pursuit of lofty goals affect those closest to one, the Board of Directors has officially named the scholarship the Richard and Joanna Sosnowski Award.

Since that day in February when so many were shocked at the loss, the endowment for the Sosnowski scholarship has grown to over \$48,600. Many individuals have made gifts of all sizes to this endowment. Some are extraordinary. Lambda Sigma of the University of Phoenix presented a gift of \$10,000 to the fund, accepted by Dr. Michael LaRocco at their ceremony this summer. An anonymous gift of \$25,000 arrived shortly after Rich's death. Eta Chapter at DePaul University, to which Rich belonged and gave much of his time, contributed \$3500. Thirty-four contributors, both group and individual, have provided funds for the endowment.

We know that some additional gifts to this fund will be made by those whose lives Rich touched, and so we are able to announce not only will we award this scholarship in 2013, but that its amount will be \$2,000. The generosity of those who knew Rich and Joanna continues to amaze us.

Speakers Confirmed for Centennial Biennial

Two individuals known for their excellence have agreed to speak at the Centennial Biennial Conference next fall. Dr. Jan Davis, a former astronaut, and Patrick Chaffin, much honored alumnus of Lipscomb, will share insights with us.

Dr. Davis has earned recognition with membership in four honor societies. She is a Fellow of the American Society of Mechanical Engineers (ASME) recognizing exceptional achievements and contributions to the engineering profession. Dr. Davis has earned a number of awards from ASME as well as honors for her work at NASA

Starting in Mission Development, Dr. Davis provided technical support for Shuttle payloads. She then served in Mission Control as Capsule Communicator (CAPCOM) for seven missions. She is a veteran of three space flights, logging 673 hours in space between 1992 and 1997. Between flights she served in various commanding roles until her retirement from NASA in 2005. She currently works for Jacobs Svederop Engineering on a contract with Marshall Space Flight Center in Huntsville, Alabama.

As Vice President of Strategic Planning and Investor Relations at Gaylord Entertainment, Patrick Chaffin didn't plan on having a pivotal role when the Cumberland River in Nashville overflowed. The 2010 flood necessitated the evacuation of the Gaylord Opryland Hotel. After working on the evacuation, he became the central point of contact for Wall Street analysts and Gaylord shareholders during the crisis, reassuring all that the firm was on top of the situation.

Chaffin handled the challenge with the business skills he's been recognized for by various organizations over the last few years. The Nashville Business Journal named him one of the "Top Forty Under 40" in 2010. He was named 2011 Young Alumnus of the Year by Lipscomb University. He serves on Lipscomb's alumni board as well as the board for the Middle Tennessee YMCA camp.

So here's one from Boston University Professor Howard Zinn, historian and political scientist in an interview in 2005:

History is instructive. And what it suggests to people is that even if they do little things, if they walk on the picket line, if they join a vigil, if they write a letter to their local newspaper, anything they do, however small, becomes part of a much, much larger sort of flow of energy. And when enough people do enough things, however small they are, then change takes place.

son's chapter of Students in Free Enterprise. The award is made in recognition of outstanding performance as a teacher and advisor and for commitment to the intellectual and personal development of students.

Mu Theta Chapter was installed in April of 2012. Dr. Ressler is its founding chapter adviser. Thirtynine members were inducted at the time the chapter was installed.

By the Numbers: Growth Tops the Charts

Any way you measure, Delta Mu Delta has grown. On the qualitative side, we offer more services and benefits than we did ten – or even five – years ago. Online communication, the eStore and induction for distance learners are among those.

By the numbers, we've grown incredibly in the last year. We added 9004 new members. New chapters were installed at eight schools this year, and total new campus chapters were 27.

Remembering Our 75th Anniversary Year

As we begin our 100th year, we begin to think about the journey of our Society from its beginnings to today. We thoughtfully peruse the records kept by those before us, noting turning points, the efforts of those special people without whom the Society might have failed to grow and prosper, and celebrations surrounding important events in our story.

Delta Mu Delta was founded in November of 1913 by five New York University (NYU) professors educated at Harvard, Yale and NYU. Three of these men had been honored for their academic success with membership in Phi Beta Kappa. All five believed that business students who excelled should be honored in a similar way. They installed the first chapter at NYU in mid January of 1914 and inducted the first students at that time. (More early history in the Spring 2006 issue ⇒ON-LINE)

In 1988, Delta Mu Delta celebrated its 75th year. At that time the Society comprised 112 active chapters with four more close to installation, and boasted just over 50,000 members. Professor A.J. Foranoce, Chairman of the School of Business at New York Institute of Technology, was the President of Delta Mu Delta. Many of the others important to DMD's growth and development were on the board at that time. Among these greats are Mildred Ruth Marion, Dr. James Giffen, Dr. Walter

Rohrs, Anthony Jablonsky, and Richard Sosnowski. You may recognize these names as scholarships and other awards have been given honoring them. Our current Executive Director, Dr. Michael LaRocco, was the Faculty Moderator for the Delta Kappa chapter at the College of Saint Francis. In that era, Society meetings were held every three years, so the 75th Anniversary Triennial was held close to the end of our 76th

year, in October of 1989. New York Institute of Technology hosted the meeting and celebration at its deSeversky Conference Center, located on a large wooded estate on Long Island. The setting was beautiful, the conference center itself elegant and the food was amazing according to those who remember it.

The meeting itself opened with a review of the history of the Society and indications of its future development given by Anthony Jablonsky. The longevity of his participation in Delta Mu Delta as well as his astuteness made him the best candidate for that sort of talk. By that time, Jablonsky had been active in the Society for 25 years, first as a Faculty Moderator, then President of the National Society for 14 years. As past-president, he became a member of both the advisory board and the finance committee. President Foranoce presented a plaque to Jablonsky honoring his 25 years of service to the Society.

Of course panel discussions and breakout sessions were held on topics that still interest us today: communication, membership, fundraising, activities and programming, and chapter meetings were discussed. One of the concerns discussed was moving the society into the information age. It was referred to as "automation" in the planning phase of the triennial. By the

time discussion notes were published, this topic bore the name "Computer Use in DMD" and contained suggestions on how computer use could benefit the chapters. One of these suggested that we time the requests for special runs to coincide with the data processing schedule. That reminds us that this was 1989 and personal computers on our desks were a rarity.

Although the suggestions for using computers to help manage chapters are ideas that we now take for granted, and even though a few are obsolete, most of the ideas for chapter management and activities are ones that we could implement today. Quite interesting are the suggestions in reference to continuity of chapter officers, recruitment of members and fundraising and scholarships. (1989's Shared Suggestions \Rightarrow ONLINE)

The 75th Anniversary Triennial was the largest that had been held up to that time. Ninety people representing 67 chapters left the conference with ideas and enthusiasm for managing their chapters. Each also left the conference with a memento of the occasion, a commemorative lucite paperweight presented to each of them, a gift from President Foranoce.

DMD's Forever Dollars Scholarship Fund

The Forever Dollars Scholarship Fund is primarily the result of many moderate sized gifts over a long period of time. The fund was started with three individual contributions of \$50 each from leaders of the Delta Mu Delta family in the 1960's. It has grown with gifts of all sorts and sizes: the consistent gifts of \$5 or \$10 every year, the gifts of \$50 or \$100 given by those able and motivated by the desire to help someone finish their education, the occasional larger gift or bequest.

We thank those who have remembered us and the students we seek to serve. We appreciate your thoughtful gifts. We hope that others will be moved to give, knowing that many small gifts given by many thoughtful people over a significant length of time will continue to grow our scholarship fund. Currently

the scholarship fund shows a balance of over \$600,000 and has provided more than \$730,000 in awards for about 955 students.

If you would like to honor someone or something special, you might want to think about a named scholarship endowment. Generally, a total contribution of \$25,000 will provide an award of \$1000 per year forever. The contribution need not be made all at one time.
